### Environmental precautions

### Methods and materials for containment and cleaning up

#### Small spill

Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. #### Appropriate engineering controls

### Environmental exposure controls

##### Hand protection
